All Nine Constitutional Amendments Pass In Hart & Statewide; No. 3 Fails In County

There were 30 ballots cast at the Hart Golden Group on Nov. 5 for the Constitutional Amendment Election. All nine propositions passed in Hart, as they did statewide.

For Castro County, there were 316 voters, and eight of the nine propositions passed. No 3, which deals with authorizing a political subdivision to extend the number of days of an exemption from ad valorem taxation that are already covered by an ad valorem tax exemption, failed by 29 votes.
