

City's Sales Tax Rebate Is Up

Hart's latest sales tax rebate of \$2,923.16 is up almost 15% over last year's figure of \$ 2,546.48. For the year, the City has received \$10,249.83, compared to the same period last year of \$9,048.39.

Dimmitt's revenue for February is down 20.23%: \$24,975.56 compared to \$31,309.79. For the year, Dimmitt has received \$87,371.14, compared to \$98,267.11 for last year.

Nazareth's payment is also down, \$2,386.31 compared to \$2,494.82. For the year, the City has received \$7,947.37, compared to \$8,170.05.

The County has received \$67,463.99 for the year, up 65.30% for the same period last year when the County's total was \$40,811.74.

State Comptroller Glenn Hegar announces the payments.
