HOME – HOMEOWNER REHABILITATION ASSISTANCE PROGRAM TO REHABILITATE/RECONSTRUCT HOME FOR LOW-INCOME HOMEOWNERS

The City of Hart has received funds through the Texas Department of Housing and Community Affairs to administer a HOME Homeowner Rehabilitation Assistance Program within the city limits of Hart, Texas. This program is designed to reconstruct homes for eligible low-income homeowners who occupy their homes.

The application period will be open from April 19, 2014 to May 18, 2014. The first ten (10) households to (1) complete and return the application information, (2) provide all requested information to verify eligibility, (3) meet all eligibility requirements and (4) agree to participate in the program will be served.

The City will host an Application Workshop to provide program information and to assist homeowners with the application materials. Applicants are encouraged to attend this workshop but are not required to participate in this workshop as an eligibility requirement.

The Application Workshop will be held April 24, 2014, at 10:00 a.m., located at Hart City Hall, 403 Broadway, Hart, Texas.

Application packets will be available for pick up at the Hart City Hall starting on April 18, 2014.
