## Athletic Handbook Undergoes A Change In Wording

The Hart School Board met November 2 and approved an amendment to the athletic handbook. Two coaches met with the Board in October and expressed their frustration with how Athletic Director/Supt. Ken Rosser had administered a policy in the handbook. The two initiated the handbook, which calls for more discipline of athletes than in the previous past.

Rosser told *The Pulse* last week that the amendment is a change in wording to help avoid liability to the school. He said that any makeup for missed practices or "production" will be at each coach's discretion. He said that the amendment came as a result of a meeting with the two coaches, Ruby Romero and Stacy Perryman, and the school's attorney, Fred Stormer of Amarillo.

When asked if he thinks it a good idea for the superintendency and athletic directorship be held by the same person, he said that it will continue for the near future.

The Pulse reporter did not attend the Nov. school board meeting. Lisa Hamilton Oglesby, who resigned as boys' cross country coach because of differences with the athletic director over the implementation of the handbook, spoke with the board in Open Forum. Open Forum sessions are not recorded for minutes. The Pulse asked Oglesby what she told the Board. She was not specific, but said she told them why she resigned.

Members present were Steven Reyna, Martha Gonzales, Elodia Rodriguez, Raul Gonzales, Vickie Chavez, Angelica Ramirez and Erasmo Mata. The amendment to the handbook was approved, with Ramirez voting against it.

In other action, the Board approved the transfer of \$1,255 from Project Graduation to the General Fund; this is money that has been in a special account for a number of years. The Pulse was told that if there is a Project Graduation, the school is no longer involved.
