Diaz, Urbina Address **Board On Cafeteria**

Ken Rosser, HISD superintendent, told *The Pulse* that the school board had asked for an "update" on the school cafeteria for the Sept. 14 meeting. This reporter, Neoma Williams, said she likely irritated some board members by asking questions, but was unable to determine what the gist of the discussion was.

This year, all students get free breakfast and lunches. When Williams asked how many students actually paid last year, Director Gloria Diaz said maybe 10 to 20. She said that on average, 245 students eat each day in the cafeteria. (The elementary students have breakfast taken to their classrooms each school day morning. This was instituted under former Supt. Alex Salazar...students learn better when they have had breakfast is the premise.)

Diaz and Esmer Urbina, a cafeteria employee, met with the Board. The school district contracts with the Region 16 Service Center in Amarillo. Most of the meals are pre-cooked and are heated for the students. Because of what The Pulse presumes are federal guidelines, no fried foods are served, and whole-wheat products are served. Williams commented that whole wheat is much healthier than white flour products, but that it takes time to acquire a taste for whole wheat, if one isn't used to it. (The premise behind the federal guidelines is to help combat obesity and diabetes, which is rampant in America.) Williams also asked what foods were thrown away because the students didn't eat them; there was no clear answer.

The school also gets commodities from the federal government. Menus are approved by the Region 16 Service Center in Amarillo.

Business Manager Teresa Montemayor said that the cost of each tray under the present arrangement with Region 16 is \$1.35. Staff pays \$2.50 per tray and "outsiders" pay \$ 3.50 for lunches.

The school can opt out of the contract with Region 16 and ask for another provider, but there will be an addidtional cost. The extra cost was mentioned at maybe \$20-30,000.

In other business, the transfer of two elementary students from Canyon, whose mother teaches at Hart Elementary was approved. Also discussed was that the kindergarten class has 25 students, and the maximum allowed by the state is
