students, with limited funding for college, face an almost impossible task of going to and finishing college. O'Connor said that these kids heard about study help, financial help, career choice guidance and community support. Several myths about college were dispelled and students were challenged to dream big and make an investment in themselves.

The following morning, a panel of five Hispanic, first-generation college students, ranging from sophomore to senior status, met with the Hart students. Each of the panelists plans to move on to higher education in engineering, education or law. The HHS students heard stories of personal sacrifice, determination and dedication.

The panelists challenged the Hart students' way of thinking about college and described how hard work and dedication can lead to a bright future.

O'Connor said upon returning to Hart, these students were eager to discuss ACT scores, GPAs and potential careers.

He adds, "This experience was completely unique, empowering my students to pursue higher education and make a lasting impact on the world."

One student, I'Lynne Marquez, said, "UT isn't just a university; it is more than that. It is family, accomplishments, determination, and a way to find yourself. UT is a way to change the world, one step at a time. UT is the future of our world and I would like to be a part of that."
