like Hart, as used to be the case most often.

I've told you before that not nearly enough people subscribe to newspapers. I have subscribed to the Plainview Herald for more than 40 years, because I lived in Plainview for a few years, because my parents read newspapers, and because I want to know what is going on in Plainview. I also subscribe to other newspapers.

On occasion, I will be in Plainview and talking to someone about something that I read in the Plainview paper. Sometimes, this person will tell me he/she doesn't read the paper. I tell them they should read it and support it. Really!
